November	WKCE Administration-Test Window For WKCE Closes	Create a schedule for possibly December, and or January for speaking portions of the assessment. The speaking test is up to approximately 15 minutes and is individually administered. Metritech mails ACCESS for ELLs® to school districts
December	ACCESS for ELL®-Test Window Opens	Schedule the speaking portion of the tests. The speaking test is up to approximately 15 minutes and is

		individually administered.
January	ACCESS for ELL Testing® Classroom Teachers	Continue testing. Speaking portion of the test. Updates regarding ELLS proficiency levels, ACCESS reports, individual learning plan. Check in with middle school and high school teachers whose classes may have changed at semester.
February	ACCESS for ELL®-Test Window Closes WKCE Reports	Package test booklets for return to Metritech Individual Reports Are Mailed to School Districts Parents Are Notified.
March	Summer School	Recommendations for support and registration.
April	Placement Discussions ACCESS for ELL®	Begin discussion about classroom placement/cluster grouping for the next school year with classroom teachers. Correction window for demographic accuracy.
May	ACCESS for ELL® Testing Parents ACCESS for ELL® Placement Discussions	Review results and data. Send results to parents. Offer interpretation if necessary. Schedule parent teacher conferences if warranted. Finalized With classroom teacher determine placement and cluster grouping.
